SMH 2022 CALL FOR PAPERS: REVISED

**88th Annual Meeting of the Society for Military History
April 28-May 1, 2022
Omni Resorts Hotel, Fort Worth**

The Society for Military History is pleased to announce a call for papers for its 88th Annual Meeting in Fort Worth, Texas.

For the 2022 meeting, the Program Committee will consider paper and panel proposals on **all topics in military history**. Submissions of pre-organized panels and roundtables are strongly encouraged and will receive preference in the selection process. Panel and paper proposals will clearly explain their topics and questions in ways that the broad membership of SMH can understand. Additionally, the SMH encourages the representation of the full diversity of its membership and especially values panel and roundtable proposals that reflect the organization's diversity of institutional affiliations, various career paths and ranks, gender, race, and ethnicity.

Proposals are welcome for complete panels, roundtables, and individual papers. Abbreviated (1 page) curriculum vitae with institutional affiliation and email address are required for all presenters, including panel chairs and commentators. They should **not** contain personal information, since CVs may be linked to the conference program on the mobile app.

- **Panel proposals** must include a panel title and 300-word abstract summarizing the theme of the panel; paper title and a 300-word abstract for each paper proposed; and a one-page professional curriculum vitae for each panelist (including the chair and commentator).
- **Roundtable proposals** must include a roundtable title, a 300-word abstract summarizing the roundtable's themes and points of discussion, and a one-page curriculum vitae for each participant (including the moderator, if any).
- Individual paper proposals are also welcome and must include a paper title, 300- word abstract of the paper, and one-page vita with email address. If accepted, individual papers will be assigned by the program committee to an appropriate panel with a chair and commentator.
- **Virtual panel or paper proposals or hybrid virtual and in person panel proposals** will be conducted via Zoom. That option can be selected in the submission portal.

Individual presenters searching for other presenters from which to create a panel should use the [Panel Builder link](#) on the SMH website.

Those who wish to volunteer to serve as chairs and commentators should notify the Program Committee Chair, Heather Venable (smhconvention2022@gmail.com) and include a one- page curriculum vitae with their message. Please include “**SMH 2022 Voluntary Chair/Commentator**” in the subject line.

Proposals will be judged according to the following criteria:

- Proposal explains the topic, research questions, methodologies, and historiographic significance to specialists and non-specialists alike. (10 points)
- Proposal presents new findings or revisions of long-held interpretations. (10 points)
- Proposal highlights how the panel will be of value to a range of SMH members, including those teaching military history courses. (5 points)
- Proposal reflects the SMH’s diversity of institutional affiliations, various career paths and ranks, gender, race, and ethnicity. (Does not apply to individual submissions) (5 points)

Participants may present one paper, serve on a roundtable, or provide panel comments. They generally may not fill more than one of these roles during the conference, with the following exceptions:

- Members who act as panel chairs may deliver a paper, serve on a roundtable, or offer comments in another session.
- Members who serve as both the chair and commentator of a single session may not present in another session unless invited to participate in Presidential or Vice- Presidential sessions.

Submit using the 2022 SMH Submission Portal at www.smhannualmeeting.org. One person will need to gather all required information for panel and roundtable submissions and enter the information in the portal. Individual paper and submissions can be made by the individual concerned. For questions about the submission process, contact the chair of the program committee, Heather Venable (smhconvention2022@gmail.com). Include “**SMH 2022 Submissions Question**” in the subject line.

The submission window closes on **1 November 2021**. The Program Committee will evaluate proposals and notify presenters of their status NLT 15 January. All accepted presenters, chairs, and commentators must be members of the Society for Military History by 15 February 2022 and must register for the conference NLT 31 March 2022 to remain on the conference program. **A Young Scholars call for papers (for BA and MA students) will be circulated o/a 15 January 2022.**

SMH COUNCIL STATEMENT

The Society for Military History council sent the following message to SMH members on 14 October 2021.

The Society for Military History is, first and foremost, a wide-ranging group of individuals united by their interest in military history and their fundamental belief that its study is essential for an informed public and a democratic society. In the past few weeks, we have engaged in collective discussions about who we are, the challenges we face, and the kind of society we aspire to be.

These discussions started when several members raised the possibility of the Society relocating the 2022 annual meeting scheduled for Fort Worth, Texas, in response to Texas Senate Bill 8, which bans abortion after six weeks, and other recently passed state laws. That query sparked related questions about whether and when the Society makes public statements on contemporary issues. On September 14, the SMH President, Pete Mansoor, issued a personal statement highlighting existing, Council-approved policy and expressing his viewpoint that it should remain in place. He had notified the Council of his intent and asked for feedback, some of which he incorporated. That letter sparked a public debate about Society governance, transparency, and inclusivity.

On September 21, the Council sent out a follow-up letter with a link to a Google form soliciting anonymous member feedback. As of this writing, the Society has received 287 responses through the Google form and an additional 55 emails sent to the SMH central office. Responses ran the gamut on many topics, revealing strong and fundamental disagreements among our members on many topics. But a clear trend that emerged from member comments was the need for the SMH to engage in reflective conversation at every level about what the Society is and how it can best reflect the needs of its members. The Council welcomes these discussions. Only through self-reflection can we grow, and only through respectful discourse can we further our primary mission.

The Council acknowledges that discussions such as these are never easy. SMH members come from a variety of educational and professional backgrounds, and they work in a range of educational settings and public history venues, both military and civilian, within and outside of the United States. Some are drawn to the Society simply because of their interest in the subject. Many of our members are federal employees, while others are active duty or retired military personnel. Some are nearing the end of long careers and others are just embarking on their historical journey. Each of us has deeply held ideological and political beliefs that inform our work, our study, and our perspectives on the present. At times, that diversity makes our discussions difficult, but it also makes our self-reflection essential.

The SMH Council recognizes and values the many questions that members have raised about the upcoming 2022 Annual Meeting, the Society's policy on making public statements, its organizational governance, transparency, and inclusion. We issue this statement following our October 11, 2022, meeting to inform the membership of our decisions, to clarify some questions, and to chart an initial path forward.

After extensive discussion, the Council affirmed that it will hold the 2022 Annual Meeting in Fort Worth. Following past practice, the Council signed a contract with the hotel in 2019, three years in

advance of the conference. Penalties for moving at this late date would be considerable—approximately \$221,000, a quarter of the SMH’s entire financial reserve—and would limit the Society’s ability to continue its work in other ways. Moreover, when the Council investigated the possibility of moving the conference, we found the short timeline made it impossible to find an alternate venue acceptable in price, accessibility, quality, and local amenities.

Second, the Council recognizes the incredible complexity of the issues at hand and reaffirms the SMH’s commitment to non-partisanship. While we acknowledge the specific concerns that set SB8 apart from other controversial pieces of legislation, we also need to acknowledge the impossibility of finding a venue situated in a city and state where all SMH members would endorse all local laws and regulations. Since 2017, following the Council’s endorsement of the American Historical Association’s statement condemning President Trump’s immigration ban, the SMH policy has been “to issue or endorse public statements only under exceptional circumstances as determined by the elected Board of Trustees, and only when such circumstances impinge upon the mission of the Society.”

The Council also recognizes, however, that a non-partisan educational organization devoted to the study of history is an entity made up of political actors. By definition, the study of war in all of its facets—politics, institutions, diplomacy, technology, logistics, families, citizens, individuals, and all of their interwoven relationships—is the study of power. Moreover, the problems historians identify, the research questions they choose to ask, the methods they employ to interrogate their sources, and the reasoned conclusions they draw are all political. These dynamics exist alongside the SMH’s institutional commitment to non-partisanship.

To that end, the Council recognizes that individual members may not wish or be able to travel to Texas for a variety of reasons, ranging from personal objection to SB8 and other legislation to health concerns in the midst of an ongoing pandemic to the realities of a large financial outlay. In recognition of these concerns, the 2022 SMH Annual Meeting in Fort Worth will be completely hybrid, as it was in 2021. The hybrid format, as well as planned Covid protocols similar to those we successfully employed in Norfolk in 2021, will allow members uncomfortable with traveling to Texas for any reason to participate. Additionally, the hybrid format allows us to reach a broader audience internationally, and among K-12 faculty, graduate students, and others who may be constrained financially, by work, by public health concerns, or by family responsibilities. Due to the significant IT costs incurred in hybrid meetings, we expect the registration fee for in-person and online registrants to be the same.

Finally, the Council appreciates the many broader concerns that members have raised regarding organizational governance, transparency, and inclusion. We recognize that we have much work to do to clearly and fully communicate with and educate the membership, and we have much work to do to recruit a more diverse membership, demographically, geographically, and intellectually.

Therefore, we reiterate our call for panel proposals for the 2022 Annual Meeting on topics related to the contemporary issues that sparked concerns from many of our members: reproduction, voting rights, pandemics, and health care, viewed broadly through the lens of military history. Military historians have written much about the intersection of each of these topics with militaries and societies around the world, in all time periods. We welcome proposals that draw our attention to those intersections, and the program committee will waive dual participation rules for participants in panels on these topics.

We also announce the creation of several panels for the upcoming meeting. In response to member requests, the Presidential Panel will focus on matters of societal governance and transparency. The Graduate Student panel “What the SMH Does for You” will feature discussions on mentorship, SMH awards, and discussions about navigating contemporary issues as a professional historian. A newly instated Board of Trustees’ Panel will welcome members to think collectively about “Planning for the SMH’s Future.”

Beyond the 2022 annual conference, the Council continues to discuss ways to hear and respond to members’ concerns. Later this week we will open a permanent feedback portal for members to provide anonymous suggestions and feedback on issues of concern. We will issue a member survey soon to solicit information and feedback, and we are examining the social media policy and its enforcement. Additionally, we will consider launching a fundraising drive to sponsor additional grants to support attendance at the Annual Meeting by those for whom attendance is prohibitive. This will be in addition to our commitment to geographically rotate the location of the meeting annually.

In closing, the SMH Council thanks our members for their deliberation and their commitment to the Society. While disagreements can be difficult, even painful, they are essential to our growth. Thank you for helping us to see where we need to improve, even for shining a light on our flaws. We look forward to continuing our work together.

GRANT AND FELLOWSHIP ANNOUNCEMENTS

The Allan R. Millett Dissertation Research Fellowship

Applicants must be full-time graduate students in an accredited graduate doctoral program and members of the Society for Military History. Applications should include a three-page, double-spaced proposal (in 12 pt. font) outlining research goals, methodology, and research budget; a 2-page maximum curriculum vitae; and a letter of support. The proposal should demonstrate a sound knowledge of the historiography, a realistic research plan, and the promise of making an important contribution to the field. The application should include a letter of support from the dissertation advisor. The deadline for proposals is January 3, 2022. The committee welcomes applications from graduate students working on any time period or region who use historical methodologies to investigate war and its consequences, militaries, and/or war and society.

Applicants should send proposals and curriculum vitae as a single PDF document in an email attachment to Professor Lorien Foote of Texas A&M University, the Chair of the Committee (lfoote@tamu.edu). Advisors should send confidential letters of support in a separate email attachment to Professor Foote. The winner will be notified after February 7, 2022.

Grimsley Fellowship Announcement

The Society for Military History (SMH) seeks a doctoral student in military history and who is a member in good standing in the SMH to fill its Mark Grimsley SMH Fellowship in Social Media. This position honors Dr. Mark Grimsley, Associate Professor of History at the Ohio State University, a widely published scholar and leading pioneer in military history social media and academic blogging. The Grimsley Fellow will serve a two-year term beginning January 1, 2022, and receive a stipend of \$2,000 per year from the SMH.

The Grimsley Fellow will join the SMH's Social Media Committee and act primarily to maintain the SMH presence on Twitter. Among other duties, the Grimsley Fellow will focus on posting abridged versions of notices that appear on the SMH Facebook Group, Facebook Page, and the SMH web site. Any student of military history currently enrolled in a doctoral program - who is also an SMH member - is eligible for the Grimsley Fellowship. - A cover letter with a statement describing how social media can benefit and be utilized by the SMH
- The applicant's CV

Society of the Cincinnati

The American Revolution Institute of the Society of the Cincinnati offers several research fellowships each year, including the Tyree-Lamb Fellowship, the Keith Armistead Carr Fellowship and fellowships sponsored by the Massachusetts Society of the Cincinnati. Each fellowship provides \$1,500 to support the cost of travel, housing, and per diem expenses for a scholar wishing to use the Institute's library for a period of at least five days. The fellowships are open to graduate students and other scholars who are conducting research that may benefit from the library's holdings.

The Institute's library collections include contemporary books, manuscripts, maps, and works of art on paper which support the in-depth study of 18th-century naval and military history and the art of war in the age of the American Revolution. The library also houses books and archives related to the formation and history of the Society of the Cincinnati, as well as materials related to the life of Larz and Isabel Anderson, whose Gilded Age home now serves as a museum, and the headquarters of the Society.

Recipients will be required to fulfill their fellowship research in the library within a period of one year from the date of the award. Further, the recipient will be required to submit a two-to-three-page written report and summary of research findings, which may be published in the Society's journal, *Cincinnati Fourteen*. In addition, the library requests a single copy of any subsequent publication (article, thesis, dissertation, or book) that may result.

The recipients for each of the fellowships will be chosen from a single round of applications.

Applicants should submit the following:

- A curriculum vitae, including educational background, publications and professional experience
- A brief outline of the research proposed (not to exceed 2 pages). Strong applications will cite specific holdings of the library.
- (For current graduate students only) Two confidential letters of recommendation from faculty or colleagues familiar with the applicant and his or her research project. Note: If letters are to be mailed independently, please include the names of recommenders when submitting the application.

Applications for the 2022 fellowships must be received by November 5, 2021. Applicants will be notified by January 14, 2022.

The Newberry Library's long-standing fellowship program provides outstanding scholars with the time, space, and community required to pursue innovative and ground-breaking scholarship. In addition to the Library's [collections](#), fellows are supported by a collegial interdisciplinary community of researchers, curators, and librarians. An array of scholarly and public programs also contributes to an engaging intellectual environment. We invite interested individuals who wish to utilize the Newberry's collections to apply for our many fellowships.

Scholars of military history may be particularly interested in [The Newberry-Pritzker Military Museum & Library Joint Fellowship](#), which provides two months of support to a military history project to be held jointly at the Newberry and the Pritzker Military Museum & Library. This fellowship is available to scholars who demonstrate a specific need for the Newberry and [Pritzker Military Museum & Library's](#) collections and is open to all fields of study. Fellows will split their time evenly between the two institutions over the course of their two months of residency.

[Long-Term Fellowships](#) are intended to support individual scholarly research and promote serious intellectual exchange through active participation in the Newberry's scholarly activities, including Fellows' Seminars and Weekly Colloquium. These residential fellowships are available to postdoctoral scholars for 4 to 9 months with a stipend of \$5,000 per month. Applicants *must* hold a PhD by the November 1 deadline.

[Short-Term Fellowships](#) are available to scholars who hold a PhD, PhD candidates, and those who hold other terminal degrees. Short-Term Fellowships are generally awarded for 1 to 2 months; unless otherwise noted the stipend is \$3,000 per month. These fellowships support individual scholarly research for those who have a specific need for the Newberry's collection and are mainly restricted to individuals who live and work outside of the Chicago metropolitan area. The deadline for short-term opportunities is December 15.

Seth Andre Myers Professorship in Global Military History

The History Department at the Ohio State University is launching a national and international search for a scholar at the rank of tenure-track Assistant Professor to fill a newly endowed position, the Seth Andre Myers Professorship in Global Military History (<https://academicjobsonline.org/ajo/jobs/19662>). We seek a colleague whose research expertise and interests in military history, broadly defined, extend beyond North America and Europe. This position is open to those studying both pre-modern and modern history. The candidate would teach history survey courses and thematic courses in military history at the undergraduate level, as well as undergraduate and graduate seminars. In addition to teaching, we expect him/her to actively contribute to the intellectual life, research profile, and reputation of our program with a long tradition in the history of war and its impact on societies.

The Irish Civil War National Conference:
University College Cork, 15-18 June 2022

On 15-18 June 2022, University College Cork (UCC) will host the Irish Civil War National Conference,

to mark the centenary of the opening of hostilities at the Four Courts in Dublin. Working with the Department of Culture, Heritage, and the Gaeltacht, this conference will align with the core principles of the Irish government's Expert Advisory Group on Commemorations by encouraging, 'multiple and plural' perspectives on complex and contested events. The four-day conference will seek to explore political, social, cultural, military, and economic dimensions to the Irish Civil war. It will also locate the Irish experience within the broader context of similar national, imperial and European political realignments following the end of the Great War. Wider historiographical and theoretical perspectives on the phenomenon of civil war, as experienced both before and since 1922-23, will also be invited to place the Irish Civil War within broader chronological and geographical frameworks. The conference will seek, neither a single agreed narrative, nor indeed a sense of 'closure'. Instead it will attempt to gather the fruits of on-going historical research in what the Expert Advisory Group describes as, 'meaningful engagements with a difficult and traumatic time'.

Short papers of 20 minutes' duration are invited on topics related to the Irish Civil War and its broader contexts, including (but not limited to) the following:

- Theoretical and comparative perspectives on civil war: Civil wars of the early twentieth century in comparative perspective; the collapse of empires, the winning of independence and the risk of civil war; the concept of a 'European civil war' and its contested intellectual genealogy.
- High politics and diplomacy of the Civil War: The Anglo-Irish Treaty, the Dáil and the Civil War; the foundation of the Irish Free State; party politics and the Treaty split; the British state and the Civil War; Northern Ireland and partition; the Civil War overseas – expatriate communities, republican and Free State foreign policy; diplomacy and relations with foreign governments.
- The military history of the Civil War: conventional and guerrilla phases; military leaders; the National Army, the anti-Treaty IRA, Cumann na mBan, and Cumann na Saoirse; tactics and technologies; atrocities of the Civil War; the culture of paramilitarism; neutrality, war-weariness, and public apathy; the Civil War in the localities; the Civil War in Ulster; urban experiences of the Civil War; prisoners and executions.
- The Irish Civil War and gender: Female TD's and the Treaty divide; masculinities and militarism; sexual violence; Gender politics and propaganda; women-led peace movements; female participants and combatants.
- Land, Labour and Class in the Irish Civil War: Class divisions of the Civil War; labour campaigns against 'militarism'; trade unions, strikes, and workers' soviets; big farmer and farm labourer experiences; trade union leaders and rank-and-file; agrarianism and the land question; the 'Big House' experience.
- Childhood and the Family during the Civil War: children and the Civil War; divided families; fratricide; homes as conflict spaces; Fianna Éireann and Clann na Gael; wartime impacts on domestic life; civil war and education.
- Civil society, religion, and Civil War: the press and public opinion; local government experiences; associational culture and the Civil War; Catholic Church responses to the Civil War; Protestant experiences; the universities and the Civil War; economic, financial, and commercial impacts.
- Governance and the Civil War: the Provisional Government and the handover of power; civil servants in the new state; emergency legislation; laws and repression; taxation and public finances; the republican parallel state; local government experiences; governance in the new Free State.

- The historiography and memory of the Irish Civil War: commemorations and memorials; memory and silences surrounding the Civil War; political legacies; impacts on Ireland's self-image; historical writing of the Civil War.
- Artistic and cultural representations of the Irish Civil War: the Civil War and visual culture, literature, music, and film; the material culture of the conflict; battlefield archaeology and preservation; the Civil War in memoir, in oral history, in archives, and in official documentation.
- The Irish Civil War beginnings and endings: continuity and discontinuity from the War of Independence to the Civil War; ending the violence; the aftermath of Civil War; civil/military relations; republican emigration; veterans and trauma; rehabilitation and the struggle for legitimacy.

The conference will be held from 15-18 June, with 20-minute papers scheduled for 16-17 June (days 2 and 3). It is planned as an in-person event on the UCC campus. Speakers will be notified of any change in public health advice.

The Coffman Prize Award Guidelines

The Society for Military History Coffman Prize is awarded annually to the best first manuscript in military history. The competition is open to scholars whose work blends military history with social, political, economic, and diplomatic history and to authors of studies centering on campaigns, leaders, technology, and doctrine. The winning author receives a cash award and a plaque. The winner also will be recognized at the Awards Dinner at the Society for Military History annual meeting. This prize is named in honor of Edward M. Coffman.

The Society for Military History First-Manuscript Prize Submission Guidelines Eligibility:

1. The dissertation must have been defended or the Ph.D. degree received in the previous calendar year, between 1 January 2021 and 31 December 2021.
2. Only English-language manuscripts will be considered. Translations are not eligible for consideration unless the author both translated and annotated the manuscript.
3. The text of a submitted manuscript must be at least 250 pages in length.
4. Submitted manuscripts should be the record copies filed with the PhD-granting university. Manuscripts may be under contract for publication in the fall of 2022 or later.

Submission Instructions:

1. No later than 3 January 2022, the author must submit a full manuscript, a 3-5-page précis of the same, and a current curriculum vitae to Dr. Ian Ona Johnson, chair of the 2021 Coffman Prize Committee, at ijohnso2@nd.edu. The précis must include a statement of the work's thesis and conclusions, its place in the relevant historiography, and any new or underutilized primary source materials or innovative methodologies that shape it.
2. All submissions must be double-spaced and submitted in PDF format.
3. The Committee will designate the winner on or about 1 March 2022.
4. The Society for Military History will present the Coffman Prize at the 2022 Annual Meeting of the Society, April 28- May 1, 2022 in Fort Worth, Texas.

Digitization Volunteers Needed

Project CHECO: The Air Force Experience in Vietnam" (<https://airforcehistory.net>) seeks to textually digitize a semi-curated collection of documents held at the Air Force archive. It also supports research into the correlation between demographics and crowdsourcing effectiveness.

The Air Force created Project CHECO (Contemporary Historical Examination of Current Operations) in 1962 to analyze issues of immediate concern to various echelons of the service. Over the course of fifteen years, authors completed more than 250 reports on topics that included special operations, conventional air operations, rules of engagement, training, air base defense, and many others. Arguably, the Project CHECO reports represent the single-most comprehensive collection of Air Force-produced documents detailing its activities in the Vietnam War. The vast majority of these have been declassified and approved for public release, and only the publicly-available studies are being used for this project.

For the volunteer, this is a trifecta of opportunities: A chance to learn about U.S. Air Force history in Southeast Asia from the perspective of the service itself; contribute to digital history through the textual digitization of a portion of the USAF archive (similar to efforts by NARA, LOC, and the Smithsonian); and, last but not least, help me gather data for my dissertation!

The process is simple:

1. Fill out a demographic form (individual identities will not be associated with performance)
2. Review some directions for the site.
3. Correct or transcribe a document from the Air Force archive.
4. Take a survey.

Naval Historical Foundation Selects Williams, Browning, and Hone to Receive Commodore Dudley W. Knox Honors

At the annual meeting of the Naval Historical Foundation (NHF) held on June 12, 2021, the chair of the recognition committee Dr. David Alan Rosenberg announced that Dr. Kathleen Broome William, and Dr. Robert M. Browning Jr., and Dr. Thomas Hone have been named as the 2021 Commodore Dudley W. Knox Medal recipients for lifetime achievement in the profession of naval history.

The award is named for Commodore Dudley Wright Knox (21 June 1877 – 11 June 1960). A graduate of the U.S. Naval Academy and Naval War College, Knox had a distinguished career as a naval officer with service in the Spanish American War, Boxer Rebellion, Great White Fleet, and World War I. But it was his abilities as a historian, librarian, and archivist that earned him respect and admiration amongst his peers and later generations.

Transferred to the Retired List of the Navy on 20 October 1921, Knox served as Officer in Charge, Office of Naval Records and Library, and as Curator for the Navy Department. The publication of his clarion call *Our Vanishing Naval History* in the Naval Institute *Proceedings* in January 1926 led to the establishment of the Naval Historical Foundation. He would serve as secretary of the organization for decades and was its president at the time of his passing in 1960.

Notes on the Recipients:

Kathleen Broome Williams

Professor Williams holds a bachelor's degree, with honors in history; a master's; and a Ph.D. from Wellesley, Columbia and City University of New York (CUNY). Prior to settling permanently as an adjunct professor at Holy Names University in Oakland, California (2014-pres.), she taught at Sophia University in Tokyo, the Panama Canal College, and CUNY. She reached her teaching pinnacle in 2018 as the tenth Class of 1957 Chair in Naval History at the U.S. Naval Academy.

Beyond the classroom, she first exhibited her fascination with applied science, the Navy and World War II in *Secret Weapon: US High-Frequency Direction Finding in the Battle of the Atlantic* (Naval Institute Press, 1996) followed by *Improbable Warriors: Women Scientists and the U.S. Navy in World War II* (Naval Institute Press, 2001), and *Grace Murray Hopper: Admiral of the Cyber Sea* (Naval Institute Press, 2004, 2013). She also published an appreciative biography of her father, a Marine who fought at Saipan in World War II: *The Measure of a Man: My Father, the Marine Corps, and Saipan* (Naval

Institute Press, 2013). In addition, she has published six chapters in other books, has written 15 scholarly articles, has delivered 50 scholarly papers at academic gatherings, and has reviewed 24 books.

Robert M. Browning, Jr.

Dr. Browning earned his master's degree at East Carolina University and his Ph.D. in History at the University of Alabama. Browning has published five monographs on American naval and maritime history between 1993 and 2015. The first of these treated the North Atlantic Blockading Squadron; it garnered the North American Society of Oceanic History's John Lyman Award (1994). Dr. Browning's latest book, *Lincoln's Trident* (2015), analyzes the West Gulf Blockading Squadron's actions in the Gulf and Mississippi River. In addition to his books, Dr. Browning has published over 50 scholarly articles, booklets and book chapters on the history of the USN and the U.S. Coast Guard, two of which appeared in *Naval History* in 2020.

He began his career as a park superintendent at the Battleship *Texas* and then joined the Coast Guard Historian's Office in 1989. Two years later he became the USCG Chief Historian until his retirement in 2015. Dr. Browning created a national historical program for the service, established area offices, developed a museum and artifact program, and instituted professional standards for the Coast Guard's archival collection. Early on, Dr. Browning assembled an "History Action" team that did yeoman's service recording the Coast Guard's role in the events following 9/11, in Operation Enduring Freedom and Iraqi Freedom, and throughout the Coast Guard's heroic responses to Hurricanes Katrina and Rita. Beyond immediate crises, Dr. Browning's relentless determination ensured that the Coast Guard Historian's Office effectively continued to maintain the service's written, oral and tangible history for the benefit of future generations of Americans.

Thomas C. Hone

Dr. Hone earned his bachelor's from the Ohio State University (1966), and a doctorate in Political Science from the University of Wisconsin at Madison (1973) and graduated the DOD's Defense Acquisition University (1988). Between 1985 and 2018 Dr. Hone held at least 13 academic positions ranging from an initial one-year stint at the Naval War College (1985-1986) through faculty positions at the George C. Marshall Center for European Studies (1994-1997), the Industrial College of the Armed Forces (1991-2001), the Faculty of Joint Military Operations Department at the Naval War College (2006-2009), to his final appointment as a contract historian with the Navy History and Heritage Command (2014-2018). He also served as Principal Deputy Director for the Office of the Secretary of Defense Office of Program Analysis and Evaluation in 2001–2002, and was Special Assistant to the Commander, Naval Air Systems Command, in 1992–1994. In 2003–2006, he was Assistant Director for Risk Management, Office of Force Transformation, Office of the Secretary of Defense.

He published his first naval history article, "Battleship vs. Aircraft Carrier," in 1977. Since then he has written at least 40 articles, book chapters, and reviews of books on naval history, ranging in topics from arms control treaties following World War I and II to portraits of pioneering naval leaders and to the early 2000s "AirSea battle concept." Dr. Hone is the co-author of the following books: the Naval History and Heritage Command Centennial *History of the Office of the Chief of Naval Operations, 1915-2015, American & British Aircraft Carrier Development, 1919–1941; Battle Line: The United States Navy, 1919–1939; Innovation in Carrier Aviation;* and Vol. 1, Part 2 of the *Gulf War Air Power Survey* as well as the author of *Power and Change: The Administrative History of the Office of the Chief of Naval Operations, 1946–1986.*
