OPEN SOURCE PUBLISHING AND THE SMH

For many outside Europe and Australia, the idea of "Open Source" remains a mystery (and often a term few recognize). However, it has begun and will continue to shape the future of journals as well as how academic organizations fund themselves in the next five years.

Four years ago, SHAFR leaders asked me to chair a task force on "Open Source." I must admit to not knowing anything about it, but I dove in and learned a great deal. Basically, the governments who sponsor a great deal of the research in Europe and Australia argue their investments should create access for everyone, instead of requiring subscriptions (often very expensive ones) to access the research. While directed primarily toward medical and STEM fields, it does reach beyond and requires researchers in the humanities and social sciences to publish in open-source outlets or secure special consideration for others.

With the system now being debated in the United States in states such as California (typically a national leader on such innovations), it is important to note this will affect journals, including the *Journal of Military History*. First, journal editors have been working overtime to adjust to the new requirements, especially those with international audiences and submissions from countries emphasizing open source.

More important, the funding models will change. At a recent meeting of the American Council of Learned Societies, I learned that the American Philosophical Association has already gone to open source with their journal. Fortunately, they planned ahead and found a way to fund the publication without too much extra cost for its members. Second, the director of the American Historical Association, Jim Grossman, informed me that Oxford University Press in the new contract for the *American Historical Review* had reduced their payments to the AHA by 40%. This is just the start of the process, and the loss of revenues will lead to higher dues and the search for other cash streams.

The same likely will happen to SMH in a couple of years when our contract with EBSCO ends. We cannot expect as generous revenues off accessing our journal. Therefore, we must make judicious economic choices, one of those starting with a line-by-line review of budgets for everything from conferences outlays to journal costs (hence, one reason I asked people last time to consider switching to electronic versions of the journal). It will be easier to make these transitions in the next couple of years,

rather than waiting for it all to come crashing down on us as open source (and of course other factors like inflation) affects the bottom line and subsequently costs including annual dues.

I simply wanted to alert people to the issue. We must all start working toward addressing the issues, and we appreciate your patience, assistance, and support in doing so.

DR. WILLIAMSON MURRAY

NOVEMBER 23, 1941 - AUGUST 1, 2023

Williamson "Wick" Murray, a giant in the field of military history, passed away peacefully on August 1 in Fairfax, Virginia. His body of work, stretching over fifty years, covered an impressive array of subjects: military theory, grand strategy, operations, and airpower. His writings not only made important contributions to academic scholarship, they exerted considerable influence on professional military development as well. He was also a passionate teacher deeply committed to his students, whether those students were undergraduates, graduate students, or military leaders.

A 1963 graduate of Yale University with honors in history, Murray served a tour of duty in the Vietnam War as a U.S. Air Force officer. Upon completion of his active-duty service, he returned to Yale and pursued a Ph.D. in military-diplomatic history, working under Hans Gatzke, one of the foremost diplomatic historians of his time, and Donald Kagan, a distinguished historian of classical Greece whose mastery of Thucydides and the Peloponnesian War inspired Murray to become a formidable authority on those subjects in his own right. Murray's doctoral dissertation resulted in a well-regarded first book, *The Change in the European Balance of Power, 1938-1939* (Princeton, 1984).

After two years as an instructor at Yale, Murray accepted a position in military-diplomatic history at The Ohio State University and, together with his colleague Allan R. Millett—himself a giant in the field of military history—created one of the first graduate programs in military history. It soon gained a reputation as one of the best. Murray and Millett collaborated on several edited volumes and co-wrote *A War to Be Won: Fighting the Second World War* (Harvard, 2000). Described by one reviewer as "a book of remarkable and compelling originality," it received widespread acclaim, not just for its scholarship but for a lucid style that made it accessible to general readers.

In classroom settings Murray was in his element, a born teacher who spoke without notes in a conversational style frequently punctuated by bursts of wry humor. He combined an obvious passion for history with a joy of performance that captivated students and instilled in many of them a passion for

history of their own. He had a strong interest in helping students to become better writers and a lifelong hatred for the passive voice. In 1987 he received the Alumni Distinguished Teaching Award, Ohio State's highest award for classroom excellence.

Murray retired from Ohio State in 1995 but continued his career through service to a number of other academic and military institutions. Among these were visiting professorships at the U.S. Air War College, U.S. Army War College (where he held the Harold Keith Johnson Chair in Military History), the U. S. Naval War College (as a Secretary of the Navy Fellow), and the U.S. Marine Corps University (where he was the Matthew C. Horner Professor of Military Theory). Other posts included the London School of Economics, the U.S. Military Academy, and the U.S. Naval Academy. He also held the Charles Lindbergh Chair at the Smithsonian Institution's Air and Space Museum.

In addition to *The Change in the European Balance of Power* and *A War to Be Won*, Murray published a wide selection of highly acclaimed articles and books, including *Luftwaffe* (Nautical and Aviation Press, 1985); *German Military Effectiveness* (Nautical and Aviation Press, 1992); *The Air War in the Persian Gulf* (Nautical and Aviation Press, 1995); *Air War, 1914-1945* (Weidenfeld and Nicholson, 1999); and *America and the Future of War: The Past as Prologue* (Hoover, 2017). In collaboration with Major General Robert Scales Jr. he co-authored *The Iraq War: A Military History* (Harvard, 2003); with Kevin Woods *The Iran-Iraq War* (Cambridge, 2014); and with Wayne Hsieh a military history of the U.S. Civil War, *A Savage War* (Princeton, 2016). He was also a major contributor to *The Cambridge History of War*, edited by Geoffrey Parker (Cambridge, 2005).

Murray edited or co-edited fifteen volumes on military effectiveness, military innovation, and grand strategy: Military Effectiveness (Allen and Unwin, 1988); Calculations: Net Assessment and the Coming of World War II (Free Press, 1992); The Making of Strategy: Rulers, States, and War (Cambridge, 1994); Military Innovations in the Interwar Period (Cambridge, 1996); The Dynamics of Military Revolution, 1300-2050 (Cambridge Press, 2001); The Past as Prologue: The Importance of History to the Military Profession (Cambridge, 2006); The Making of Peace: Rulers, States, and the Aftermath of War (Cambridge, 2009); Conflicting Currents: Japan and the United States (Praeger, 2009); The Shaping of Grand Strategy: Policy, Diplomacy, and War (Cambridge, 2011); War Strategy and Military Effectiveness (Cambridge, 2011); Military Adaptation in War: With Fear of Change (Cambridge, 2011); Hybrid Warfare: Fighting Complex Opponents from the Ancient World to the Present (Cambridge, 2012); Successful Strategies (Cambridge, 2014); Grand Strategy and Coalition Warfare (Cambridge, 2016); and The Culture of Military Organizations (Cambridge, 2019).

In 2019 the Society for Military History honored Murray with the Samuel Eliot Morison Prize for lifetime achievement in the field of military history.

At the time of his passing, Murray was finalizing the publication of a history of military revolutions, *The Dark Path: The Structure of War and the Rise of the West, 1500 to the Twenty-First Century*, with Yale University Press.

Murray is survived by his wife Lesley Smith, his children Alexandra Murray and Spencer Murray, and five grandchildren.

SEEKING COFFMAN AWARD SUBMISSIONS

The Society for Military History Coffman First Manuscript Award is given annually to the best dissertation in military history. The award is named in honor of Dr. Edward M. Coffman. The competition is open to PhD scholars whose work blends military history with social, political, economic, and diplomatic history and to authors of studies centering on campaigns, leaders, technology, and doctrine. The winning author receives a cash award and a plaque. The winner also is recognized at the awards dinner at the Society for Military History annual meeting.

Society for Military History First Manuscript Prize Submission Guidelines Eligibility:

- 1. The dissertation must have been defended or the PhD degree received in the 2023 calendar year (between 1 January 2023 and 31 December 2023).
- 2. Only English-language manuscripts will be considered. Translations are not eligible for consideration unless the author both translated and annotated the manuscript.
- 3. The text of a submitted manuscript must be at least 250 pages in length.
- 4. Submitted manuscripts should be the record copies filed with the PhD-granting university. Manuscripts may be under contract for publication in the fall of 2024 or later.

Submission Instructions:

- 1. No later than 15 December 2023, the author must submit a copy of the full manuscript, a 3-5 page précis of the same, and a current curriculum vitae to Elizabeth A. Coble, chair of the 2024 Coffman First Manuscript Award Committee, at <u>ABNATW@gmail.com</u>.
- 2. The précis must include a statement of the work's thesis and conclusions, its place in the relevant historiography, and any new or underused primary source materials or innovative methodologies that shape it.
- 3. All submissions must be double-spaced and submitted in PDF format.
- 4. The Committee will designate the winner on or about 20 February 2024.
- 5. The Society for Military History will present the Coffman First Manuscript Award at its 2024 Annual Meeting, 18-21 April 2024, in Arlington, VA.

SEEKING MILLETT DISSERTATION AWARD SUBMISSIONS

Applicants must be full-time graduate students in an accredited graduate doctoral program and members of the Society for Military History. Applications should include a three-page, double-spaced proposal (in 12 pt. font) outlining research goals, methodology, and research budget; a 2-page maximum curriculum vitae; and a letter of support. The proposal should demonstrate a sound knowledge of the historiography, a realistic research plan, and the promise of making an important contribution to the field. The application should include a letter of support from the dissertation advisor. The deadline for proposals is **December 28, 2023**. The committee welcomes applications from graduate students working on any time period or region who use historical methodologies to investigate war and its consequences, militaries, and/or war and society.

Applicants should send proposals and curriculum vitae as a single PDF document in an email attachment to Professor Lorien Foote of Texas A&M University, the Chair of the Committee (Ifoote@tamu.edu). Advisors should send confidential letters of support in a separate email attachment to Professor Foote. The winner will be notified by January 31, 2024.

Procedures

- 1 Committee chair will receive applications and letters of support, then upload all materials to the Millett Committee team drive.
- 2 Committee members will have access to this drive provided to them by the SMH.
- After the application deadline, the committee chair will check to see that all recommendation letters have been received. In the case of outstanding letters, the chair will contact the dissertation advisor and give her or him an extra couple of days to submit the letter.
- 4 Committee members will review all applications and keep notes of their assessment of each application.
- 5 The committee members will all submit their top three choices to the committee chair by January 31.
- 6 Over the next few days, the committee will deliberate either via email or zoom conference to arrive at an award winner.
- 7 In the event that the committee does not arrive at consensus, a vote will determine the winner.
- 8 If the committee does not arrive at a winner on the first ballot, run-off elections will be held until one applicant receives at least two of the three votes.
- 9 Committee chair will notify the award winner.
- 10 Committee chair will notify the other applicants of the committee's decision only after the winner has accepted the award.
- 11 Committee chair will notify the SMH president and vice president of the committee's decision.
- 12 Committee chair will upload all pertinent communication regarding the deliberations to the Millett Committee team drive.

Evaluation Rubric (65 points total)

To ensure the committee members evaluate proposals on the same criteria, they should use the following rubric.

(10 points)

Proposal clearly describes the project's topic in a way that is understandable to anyone familiar with military history.

(10 points)

Research goals are clearly stated and appear reasonable. Author outlines appropriate archives, libraries, or sources and has a clear plan for pursuing this research. Research will clearly advance the project.

(20 points)

Proposal makes a clear intervention in existing historiography about the specific topic. A proposal about Napoleon will make clear, for example, how the author's conclusions will change or reframe what historians think about Napoleon.

(20 points)

Proposal demonstrates how the project will make important contributions to the broader field of military history. It should be clear, for example, how a project on Napoleon will be important for all historians, not just those interested in Napoleon. Historians of all persuasions should be able to grasp the historical significance of the project.

(5 points)

Recommendation suggests confidence in the proposal and the author's ability to produce an admirable dissertation.

CALL FOR NOMINATIONS: 2024 VANDERVORT PRIZE

The Vandervort Prizes recognize outstanding journal articles that contribute to the field of military history.

The Vandervort Prizes honor the *Journal of Military History*'s longtime editor, the late <u>Dr. Bruce Vandervort</u>. A prize is awarded to at least two of the best articles published in *The Journal of Military History* during the previous calendar year, as well as up to two articles published outside of the journal.

All articles published in *The Journal of Military History* are automatically considered for the Vandervort Prizes.

The selection committee is seeking nominations of outstanding articles published in other journals. These should be articles published in peer-reviewed academic journals, in English, with a publication date of 2023. The journal itself need not focus on military history, as we are seeking to recognize scholarship that shows the intellectual breadth of our discipline.

- 14 Authors must be actively enrolled undergraduate students or recent graduates who received undergraduate degrees within the last 12 months.
- 15 Submissions must have been written during the author's undergraduate studies.
- 16 Authors may only submit one paper for consideration per publication cycle. However, if a paper was categorized as "revise and resubmit" during Round 1, authors are invited to revise their papers and resubmit for further review in Round 2.
- 17 Papers based on original research are the strongest submissions.
- 18 Article submissions should not be under consideration with other publishers or have been previously published.
- 19 Submissions must be in Microsoft Word (not Adobe PDF) format with Chicago-style footnotes.
- 20 Authors wishing to include images with their articles must obtain and provide proof of copyright permission prior to submission.
- 21 The recommended word count is 2,500-6,000 words, but the editors welcome submissions of any length.

Report is an open-access undergraduate journal based in the Department of History at the United States Military Academy. The journal is published annually by the West Point Press and edited by a team of undergraduate students and faculty advisors. The journal provides a platform to showcase the historical scholarship produced by undergraduate authors. Call for Papers

Fort Ticonderoga Seminar on the American Revolution September 20-22, 2024

In 2024, Fort Ticonderoga embarks on our multi-year commemoration of the 250th anniversary of the American Revolution. Fort Ticonderoga seeks to explore both the local and global events of the Revolutionary War, through new exhibits, programs, and the beginning of our unique REAL TIME REVOLUTIONTM interpretive experience.

In 2024, the museum opens a new Exhibition, A Revolutionary Anthology, displaying material from Fort Ticonderoga's unparalleled collection to explore the breadth of the revolutionary experience through its material culture. Beginning in 2024, the contents of this exhibition will change annually to reflect a series of interpretive themes designed to focus on aspects of the Revolutionary era, its participants, events, and repercussions.

The first of these installations explores the theme Power of Place. The American Revolution and the War of Independence played out across a vast geography. The Revolution made an impact in all corners of the world, far from political centers or even the combatant nations; but the specific history and geography of places in North America like Ticonderoga channeled and condensed this revolutionary human activity. This concentrated people, actions, and events in unique ways. Geography, topography, and hydrology shaped the Revolutionary struggle in profound ways that gave places far from population centers profound significance for political and military events that had a lasting effect on individuals and nations and whose remains can still be traced across the land to this day.

The Fort Ticonderoga Museum seeks proposals for our twentieth annual Seminar on the American Revolution. We encourage papers from established scholars, graduate students, and others related to the theme Power of Place, and are especially interested in papers that engage with the geography of the Revolutionary world. This can be in terms of military campaigns, archaeology, biography, cartography, or regional histories, across any number of disciplines that address the period and places of the global American War for Independence.

Selected submissions on the theme Power of Place may be published in the subsequent volume of the *Bulletin of the Fort Ticonderoga Museum*. In print since 1927, the *Bulletin* is the museum's venerable publication and will embark upon a thematic series of volumes mirroring the themes of our 250th anniversary commemoration to preserve in print new research on the period for posterity. Submitting an abstract for consideration for publication is not required, and we welcome abstracts for papers alone, or for publication.

Sessions are 30 minutes in length followed by 10 minutes for audience questions. Fort Ticonderoga may provide speakers with partial travel reimbursement. All Roads Lead to Gettysburg:

The Battle of Gettysburg, July 1-3, 1863, ranks as the most famous battle in U.S. history, and with good reason. Involving an estimated 160,000 soldiers (85,000 Union and 75,000 Confederate), it was the largest engagement waged in the Western Hemisphere, and it produced up to 51,000 casualties. Devotees herald Gettysburg as the Civil War's turning point, but that ignores the fact that the following year witnessed even more bloodletting than 1863, and the mounting carnage came close to sapping the Union's will to continue to crush the Confederacy.

Nevertheless, Gettysburg has acquired an allure that surpasses that of all other Civil War battles. That stems from its size, the many dramatic incidents that spelled the difference between victory and defeat, and the moving words Abraham Lincoln uttered while consecrating the battlefield's national cemetery. Gettysburg became a mecca for veterans, their descendants, and generations of students.

It is widely believed that more has been written about Gettysburg than any other American battle. That begs the question, Is there anything new to be said about that three-day orgy of mass murder? Judging from scholarship over the past generation, the answer is yes. Some scholars provide fresh insights into military issues that have dominated Gettysburg debates. Others have tapped political and social history to tell us more about the men who clashed on that hallowed ground. Gettysburg's popularity as a tourist attraction has also inspired a series of memory and material culture studies. While the guns may have fallen silent, historians continue to exchange verbal salvoes over Gettysburg's history and meaning.

The Center for the Study of Force and Diplomacy (CENFAD) at Temple University, along with its cosponsors (the Temple History and Political Science Departments and the Society for Military History),

will hold a 24-hour conference bringing together scholars of Gettysburg. We welcome all scholars to submit individual paper proposals that address any theme related to the battle of Gettysburg. Among these are:

General Omar N. Bradley Fellowships in Military History

Each year the General Omar Bradley Foundation offers \$2000 research fellowships to up to ten Army officers engaged in research related to military history. The Omar Nelson Bradley Fellowships selection committee consists of members of the Department of History of the United States Military Academy appointed by the Professor and Head, Department of History, United States Military Academy. Selection of the Fellows will be made without regard to rank, branch, or affiliation with the USMA Department of History. Funds will be granted to those officers who are actively engaged in original, archival historical research (including digital humanities research and digital research in archival sources) and have the best developed plans for conducting significant historical work. Research should be in pursuit of a graduate degree or scholarly publication. The committee will recommend a slate of ten proposed Omar Nelson Bradley Fellows to the Directors of the Omar Nelson Bradley Foundation by January 15, 2024 with the aim of a final announcement of recipients by February 15, 2024.

Who May Apply. U.S. Army officers who are actively engaged in the study of military history may apply for these fellowships. Reserve officers may apply, but preference will be given to individuals on active duty. "Active engagement in the study of military history" includes research toward a master's degree or doctorate in military history or research toward a scholarly article or monograph in military history, and can include digital humanities projects (the creation of databases, map collections, and the like).

The selection committee interprets "military history" in the broadest sense. 

Congratulations to Sarah Parry Myers for the publication of Earning Their Wings: The WASPs of World War II and the Fight for Veteran Recognition by UNC Press. Established by the Army Air Force in 1943, the Women's Airforce Service Pilots (WASP) program opened to civilian women with a pilot's license who could afford to pay for their own transportation, training, and uniforms. Despite their highly developed skill set, rigorous training, and often dangerous work, the women of WASP were not granted military status until 1977, denied over three decades of Army Air Force benefits as well as the honor and respect given to male and female World War II veterans of other branches. Sarah Parry Myers not only offers a history of this short-lived program but considers its long-term consequences for the women who participated and subsequent generations of servicewomen and activists.
